# PROPERTY PURCHASED

**ALONG GIBSON PARK** 

In October 2023, North East Community Foundation announced its purchase of

property along Gibson Park to be used as the first ever offices of the foundation.



The 8-10 Gibson Street property was identified as a perfect fit for our initiative to have a physical presence in North East, said Kelly Montefiori, chair of the NECF building committee.

"We were thrilled to purchase the historic property," she added, explaining once the prior tenants moved out in late spring 2024, NECF board members began meeting with prospective tenants and hired Weber Murphy Fox to assist in preliminary planning and best use scenarios.

In September 2024, the building committee made a presentation at the NECF board meeting with concept designs and projected expenses for the 8-10 Gibson Street property.

"NECF hopes the space will be become a hub for other non-profits to meet and/or have office space for the primary purpose of making North East a better place to live," Montefiori said.

Upon approval of the preliminary plans, the next phase will include fundraising for the much needed renovations of the property and selection of design architects and contractors.

Full occupancy is expected in fall of 2025.


